
WHO ARE WE?

1. SHARED FUTURE

- Integrated education
- Mixed communities & inclusive public spaces
- Commissions to resolve contentious issues
- (flags, parading, the past)
- No paramilitary flags, symbolism or territory marking
- Political parties, politicians and activists need to acknowledge that the killing of innocent people is always wrong & there can never be any excuse for it. Whether it be by the armed forces or paramilitary organisations, we must never seek to hero worship them

2. FIXING OUR POLITICS

- Reassess the terms of the GFA including moving away from mandatory coalition, abolishing or reforming the Petition of Concern and ridding the Assembly of Unionist/Nationalist designations
- End the secrecy of historical party donations
- Right to vote from the age of 16
- Replace the House of Lords with an elected Senate
- Special advisors in Stormont to be selected via employment trawl rather than chosen by Ministers
- Automatic voter registration once a person turns 16 years of age
- Easier access to mail in voting
- Investigations into the incorporation of electronic voting to our current system
- Look at moving "polling day" for all elections being on public/bank holidays, and/or changing them to be over at least 2 days so as to encourage greater public participation in elections

- Reform the libel law in Northern Ireland
- Ban on MLAs employing family as staff
- Reduction of Assembly terms from 5 years to 4 years to strengthen accountability and give the public a say in direct democracy more often

VOTE

- The NI Executive should provide clarity on the processes of the Executive in their decision making
- The NI Executive should publish minutes of Executive meetings within an appropriate time period after meetings
- Legislate for a binding Citizens Assembly mechanism in Northern Ireland for regional and local policymaking

3. HEALTH & SAFETY

- Properly funded & restructured health service that addresses the current shortcomings within the service & needs of the population
- Address the problems in Emergency Departments and Waiting Lists in Hospitals.
- No to privatisation of our NHS.
- More resources to tackle the issue of human trafficking
- migrants
- Above inflation pay rises for all HSC / NHS workers
- Mandatory First Aid and Medical & Digital Literacy Training in education
- National Care Service bring care services under public control just like the NHS
- Force the social media giants to take realistic steps to tackle all forms of online abuse.
- Ban the smacking of children
- Defibrillators must be compulsory in all public buildings including education & sports venues



- Misinformation Action Plan should be developed to address the disturbing rise of misinformation within society & the negative influence it has on public life
- HSC Trusts should make improved efforts to involve people from the respective communities in the decision making of the future health services in areas including better advertisements
- Improvement of support services for refugees & The GMC (General Medical Council) should be able to carry out hearings & investigations into the work of former members on when the relevant medical professional was a member
 - Develop & act on a plan to end the accepted practice & overuse of agency workers in HSC / the NHS, except in true emergency situations
 - The Department of Health & Public Health Agency to develop a plan to greater educate the public on the emergency care options within their local communities, including GP Out of Hours, Phone First services, Urgent Care Centres & Minor Injury Units, to help ease the burden on emergency departments
 - Legislate to introduce the Right to Die for patients within the health service
 - As well as a fair pay rise, domiciliary care workers must receive appropriate compensation & travel costs for work related activities
 - Primary Care multi-disciplinary teams in GPs the Department of Health to continue & expand the roll out of MDTs at general practices to include First Contact Physiotherapists, Social Workers & Mental Health Practitioners
 - Enshrine in law, and appoint the appropriate oversight and enforcement body for, the Right to Food
 - Raise the age of criminal responsibility to 14

4. MENTAL HEALTH

- Restructuring of Mental Health Services
- Additional Funding for Mental Health Services
- Fully deliver the Suicide Prevention Strategy
- All workplaces to have Mental Health First Aiders
- Greater education of mental health issues in schools, further education environments & workplaces
- Fully fund treatment and research of psilocybin-assisted therapy for mental disorders such as treatment-resistant depression and major depressive disorder
- Fully funded mental health wellbeing centres as an alternative to psychiatric wards

5. HOUSING & HOMELESSNESS

- Urgent legislation to tackle the growing homelessness problem
- Tax landlords for empty properties
- Have rent caps on properties
- Abolish application administration fees
- Human Right to Housing
- Vacant land tax or the option to receive grants for "rewilding" and planting of native species to those who own vacant land
- Further regulation of Houses of Multiple Occupancy
- Tenants to have greater rights to security of tenure in private rental housing and protection from no fault eviction
- Legislation to prohibit the discriminatory practice of refusing tenancies to those in receipt of social security benefits
- Propose a legislative cap on holiday homes, in seaside towns
- Introduce an enforceable Charter for Renters Rights
- Mandate third party surveillance of homeless and emergency shelters

6. FAMILY

- Government should provide the option of free & quality childcare for all children under school age
- All employers to provide a minimum of 4 weeks paid paternity leave for new nongestational parents
- Government to subsidise school uniforms so they are supplied to all free of charge & schools should move to more standardised uniforms
- Free & nutritional school meals for all pupils

7. EDUCATION

- Abolition of tuition fees
- Greater education on areas like LGBT rights, Mental Health, Money management and Sex Education
- Greater awareness of neurodiverse conditions for both students & teaching staff
- Revert the cuts to the student nursing bursary & extend to all health & social care students
- Compulsory, comprehensive and standardised relationships and sexuality education (RSE) in schools
- Greater need for political education in schools, higher education & workplaces.
- Introduce 'Activism' as a compulsory school module
- Greater funding for both SEN schools and SEN pupils in mainstream schools, as well as more training and access to resources for staff/practitioners to support SEN
- Equal opportunities and access to higher education for all
- A reform of the RE curriculum to remove the Christian centric nature of the curriculum and provide more of a general education in world religions, philosophies and ethics to increase inclusivity as schools become more multi-cultural
- Education classes/resources held by local community centres/schools to offer support and networks for new parents and families (e.g parenting classes, homework support classes, play groups) and more funding for programmes like Sure Start



8. CLIMATE

- Ban toxic mineral extraction in Northern Ireland
- Modern developments to our utility and transport infrastructures to aid with the transition period to a circular economy
- A crackdown on environmentally harmful acts & the strengthening of legislation regarding this.
- An independent Environmental Protection Agency for NI to provide oversight and regulation across both the private and public sector
- Reduce CO2 emissions through the promotion of renewable & sustainable methods – introduce a Climate Change Act and incentivise the switch away from fossil fuels
- Achieve net-zero carbon emissions by 2035 through a gradual change to entirely sustainable materials, services and energy generation methods whilst utilising carbon capture & recycle method

- Rights of Nature Act for Northern Ireland
- Ban petroleum licensing
- Remove the statutory obligation on government in Northern Ireland to support the exploration and extraction of fossil fuels
- Deliver a Green New Deal for Northern Ireland
- Firewall between policymakers and mine / fossil fuel industries
- Department for the Economy should release the Hatch Report, commissioned from Hatch Generis on the economic feasibility of natural gas extraction in Northern Ireland
- Bring Lough Neagh into public ownership
- Suspend sand dredging in Lough Neagh, pending independent scientific analysis and public consultation
- Full implementation of Climate Change Act 2022
- Rescind and have no repeat of Memorandum of Understandings with NFU to minimise and castrate prosecution of ecocidal farming activities
- Deliver zero-carbon energy public transport across NI

- Introduce a ban on new fossil fuel infrastructure, investments, and subsidies (onshore and offshore)
- Insulate homes region-wide to green standards, and install heat pumps in each
- Mandatory divestment of public anchor institutions from fossil fuel industry
- Introduce a ban on fossil fuel industry advertising
- Public enquiry into the relationship between the utilities regulator and the energy industry
- Public enquiry into the relationship between the NI Environment Agency and NFU
- Insert Climate and Ecological emergency declarations into mandates of public authorities (ie utility regulator)
- Expand public financial aid to cooperative energy, food supply, and housing (including new builds and startups)
- Where the planting of trees & other plants occurs, e.g. carbon capture, only native species should be used in order to promote biodiversity & avoid invasive monocultures
- Deliver zero-carbon energy public transport across NI
- Publicly funded universal retrofitting of private and social housing to align with climate and ecological objectives
- Introduce a binding Citizens Assembly on Climate and Ecological Justice for the UK, or for Northern Ireland
- Deliver a government commissioned review into how NIs formal education system is preparing students for the climate emergency and ecological crisis
- Include the climate emergency and ecological crisis in teacher training, and a new professional teaching qualification
- Increase the priority of environmental sustainability in schools, including green infrastructure, sustainability inspections, and sustainability rankings
- Deliver a Northern Irish Climate and Biodiversity Emergency Education Act
- Windfall tax on fossil fuel energy activities (fossil fuel energy companies and private investments therein)

9. ETHNIC MINORITIES

- Implement all points in the Racial Equality Strategy 2015 – 2025
- Ethnic Monitoring to be implemented
- Race Relations Order 1997 to be updated
- Refugee Integration Strategy to be implemented
- Education in schools on race and minority issues includingBlack History Months in both primary & secondary schools
- Change of CTA rules to extend rights and privileges to nonCTA residents with rights to work, study and live in the island of Ireland
- Stormont should appoint an Independent Advisor on Racial Equality to provide expertise, insight & advice to theExecutive on achieving progress
- Develop a Regional Roma Integration Strategy to address the inequality of the community in four key areas; Housing,Education, Employment & Healthcare
- Recognise the cultural rights of the Irish Traveller Community to live their traditional lifestyle and to provide appropriate sites for Traveller accommodation with sufficient access to essential utilities
- End the Immigration Health Surcharge
- Scrap the policy of deporting asylum seekers to Rwanda
- The British government should develop safe routes for asylum seekers to reach the UK
- Lift the ban on asylum seekers that stops them from gaining employment in their country of asylum while their application is being processed
- There should be an investigation into The Mears Group & their practices in housing asylum seekers on behalf of the government & review of their contract

10. LGBTQ+

- Ban all forms of conversion therapy
- Require the Health Minister to accept SaBTO recommendations on blood donor criteria
- Gender Recognition Act for NI
- Support trans women right to be on all-women shortlists
- Support for greater education on trans issues for all ages in schools & workplaces
- Stop homophobic & transphobic bullying in schools & workplaces

- Adoption equality for LGBT couples is implemented
- Trans healthcare services needs to improve.
- Data collection by public & government agencies on LGBT hate crimes needs to improve
- People should be able to self ID with the gender they identify with
- Waiting times in Trans healthcare including access to puberty blockers, surgery & counselling services should be reduced

11. WOMEN'S RIGHTS

- Services should be commissioned by the Health Highlight the need to stop female genital Minister to allow for free, safe & legal abortions
- The Protest Buffer Zones legislation, that allows
 The legislation that would see that period for those seeking abortions & other forms of healthcare to do so without facing abuse, needs to be implemented
- Introduce gender quotas for elections

- products is available in all public buildings needs implemented
- The full implementation of the Violence Against Women & Girls Strategy in Northern Ireland

12. WORKER'S RIGHTS & BUSINESS

- Above inflation pay rises for all public sector workers
- Legislation brought through to protect workers tips from their employers.
- Give workers "working from home" flexibility where applicable
- Move to a 4-day working week where possible
- Outlaw fire & rehire
- Increase the income tax personal allowance from £12,570 to £25,000
- Ban zero hours contracts



- No reduction to corporation tax & increase it to 26% for larger companies
- Stricter transfer pricing regulations. With the added clause that no existing large company may offshore their HQs within ten years of the start of the legislation
- The minimum wage should be the same for everyone, irrespective of age
- Reduce required notice period for a trade union to take industrial action to two days
- Reduce minimum number of employees needed for an employer to consider recognition of a trade union and a request for industrial action to 5 employees
- Remove the requirement for a postal ballot process when unions are deciding on industrial action
- Extend the right to challenge dismissal for partaking in industrial action to five years
- Legalise the right to strike in solidarity action
- Legalise the right to strike in climate and ecological action
- Support the right of frontline and essential workers to take all forms of industrial action

13. AUSTERITY

- Every adult to receive Universal Basic Income
- Current welfare programs like Universal Credit, PIP & Work Capability Assessment need reformed
- Abolish the Bedroom Tax
- Reverse austerity cuts in the community in important sectors such as the arts, youth clubs and sports
- Scrap pay-to-use ATM machines
- Supermarkets, restaurants cafes & other businesses must donate unused food to food banks
- Return the £20 Universal Credit uplift until a new welfare program is ready to replace Universal Credit

14. REGIONAL INVESTMENT

- Require infrastructure spending and capital investment in the most deprived regions, based on need - not just Belfast
- Improve transport routes in the West with a high priority on train routes
- Councils program for regeneration of town centres
- Give Councils greater powers to take steps to pedestrianisestreets in towns & cities
- Get rid of The Surrender Principle in hospitality

 The principle at the moment means there are only a set number of licences in Northern
 Ireland and if you want to open a pub or off-licence you have to obtain a licence from an existing business which is giving up its licence
- Social Value Act for Northern Ireland to entrench community wealth building into regional and local government



15. PUBLIC SECTOR

- Broadband free to all at the point of use
- Stop the creeping privatisation into our public services like the Housing Executive & Translink
- An overall review into the PSNI as an organisation - including but not limited to their handling of cases and the practices & culture within the organisation with a view to taking the necessary steps to improve public confidence in them
- Statutory support & funding for the recovery from the pandemic
- Develop a Northern Mutual Bank which moves away from the privatised system that currently exists & towards a democratised system that gives each person involved a say in how our money can be used for our benefit & the benefit of our region
- Replace Translink with a public transport system that is free to use at the point of use
- Bring electricity grid into public ownership

16. DRUG LAW REFORM

- Creation of a safe & regulated market for the selling of & personal use of cannabis
- Decriminalise drug use so it is not viewed as a criminal justice matter & to focus on a healthcare based approach
- Expansion of support services to help those who misuse drugs to quit

17. LANGUAGES, CULTURE & ARTS

- Irish Language Act and protections for Ulster Scots
- Sign Language (British & Irish) to be protected languages
- Government subsidiaries on foreign language courses
- More funding should be made available for the Arts Council to make available for grants

18. ANIMAL WELFARE

- Outlaw animal hunting with a dogs (fox hunting, etc.)
- Ban on puppy farms, third-party sales of animals, and reformation of breeding standards to prioritise health



- Recognise the Cancard as a validated indication of medical cannabis usage
- Safe drug consumption rooms & needle exchange programs should be rolled out region wide so as to give those with addiction issues safe options until they can seek help
- Adequate support for the Arts Council should be put in place so they are in a position to process more grant applications & within more appropriate timescales
- Government should seek to provide studio spaces in towns & cities for creatives to use, including incentivising building owners to offer empty properties as spaces if they are temporarily being unused
- Seabins to be installed at docks and marinas to protect marine life
- Harmful pesticides & insecticides to be banned
- Delivery of the All-Ireland Pollinator Plan across Government and Councils
- Oppose unsustainable agriculture and factory farming
- Ban badger culling, and move towards scienceled control of bTB, including frequent testing and vaccination programmes
- Stricter sentencing for those convicted of animal cruelty offences and the introduction of an animal cruelty register

19. DISABILITY RIGHTS

- Incorporate United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) into law in NI
- Greater education of disabilities taught in schools, further education & workplaces
- Repeal the Personal Independence Payment (PIP) benefit and associated assessment for a better alternative
- Repeal the Work Capability legislation, including the associated assessment and adopt a human rights approach
- Protected time off work for carers
- Harry's Law legislation to protect children with disabilities in education



- Develop legislation which recognises that children under 16 (including disabled children) can exercise legal capacity with support
- Reform the Mental Capacity Act 2016 to remove discrimination on the basis of disability in the context of deprivation of liberty
- Re-open the Independent Living Fund to new applicants
- Develop Adult Safeguarding legislation to create single source of evidence on violence, exploitation and abuse of d/Deaf and disabled people within care systems in NI
- Data monitoring by public & government agencies must be improved

20. SECULARISM

- Separation of church and state
- Equality of all religions and beliefs before the law
- Equality for nonreligious and minority faith groups
- End the Blasphemy Law

21. INTERNATIONALISM

- Oppose unnecessary military involvement in local or foreign conflicts
- No hard border in Ireland
- Irish border poll
- Support the BDS (Boycott, Divest, Sanctions) movement
- Solidarity with culturally distinct regions to have the democratic right to selfdetermination, for e.g. Catalonia, Palestine, Hong Kong, etc.
